Interested service providers will be expected to submit the prices with the following compulsory requirements:

- Valid TAX Clearance certificate issued by SARS
- **Company Registration documents**
- Companies' and/or Directors' proof of payment for the Municipal accounts (rates & taxes) in their area of jurisdiction. (Not older than Three (3) months and not in arrears for more than 90 days)..
- List of similar successfully executed projects with clients contact details and contract values.

Where possible we also request to be provided with the company profile.

NB: Service providers must submit their BBBEE verification certificate from verification agency accredited by South African accreditation system (SANAS) or a registered auditor approved by the Independent Regulatory Board (IRBA) or an Accounting Officer as contemplated in the corporation and BEE Rating certificate

Bids will be assessed under the provisions of the following Acts and its Regulations: Municipal Finance Management Act, (Act 56 of 2003); Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Supply Chain Management Policy of the Municipality in accordance with the specifications and in terms of **80:20 preferential points system**.

Sealed bids must be submitted in envelopes clearly indicating **"BID NO.15/2014/2015: SUPPLY OF VEHICLES"** on the outside and must reach the undersigned by depositing it into the official Bid Box at the front of the main entrance to the Civic Centre, by no later than **11H00 on 02 September 2014** All Bids received will be opened in public in the Municipality's Board Room, Civic Centre, Old Agriven Building, Thohoyandou.
