Thulamela Municipality hereby invites experienced service providers for the provision of supplementary valuations for properties in the entire Municipality.

Bid documents will be available as from the 22 October 2012 between 08h00 and 15h30 upon non-refundable cash payment of **R121-00** per document at office no. 02, Thulamela Municipality, Old Agriven Building, Thohoyandou.

Interested service providers will be expected to submit their proposals with the following compulsory requirements.

- ❖ An Original Valid Tax Clearance Certificate issued by SARS
- ❖ Proof of updated payments of all the services in the municipality in which the business is registered or where the owner of business resides not older than 3 months.
- ❖ Company registration documents
- ❖ Proof of professional registration with the council for professional valuer

Where possible we also request to be provided with the company profile .

NB: Service providers must submit their BBBEE Verification certificate from verification agency accredited by South African accreditation system (SANAS) or a registered auditor approved by the Independent Regulatory Board (IRBA) or an Accounting Officer as contemplated in the corporation act (CCA) in order to claim preference points.

The bids documents must be submitted in a sealed envelope clearly indicating the project name and Notice number – **NOTICE 15/2012/2013- “PROVISION OF SUPPLEMENTARY VALUATIONS”** on the outside and must be deposited in the Tender Box at the Municipality Offices, not later than 11:00 on the 30th October 2012.

Bids will be evaluated under the provisions of the following Acts and its Regulations, Municipal Finance Management Act, 2000 (Act 5 of 2000) Supply Chain Management Policy of the municipality in accordance with the specification and in terms of **80:20 preferential points system**.
