1.3. THIS BID IS SUBJECT TO THE PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT AND THE PREFERENTIAL PROCUREMENT REGULATIONS, 2017, THE GENERAL CONDITIONS OF CONTRACT (GCC) AND, IF APPLICABLE, ANY OTHER SPECIAL CONDITIONS OF CONTRACT.

- ❖ Company registration documents (e.g. CK).
- ❖ Proof of registration with ECSA and SACAP of proposed project engineer and architect respectively.
- ❖ Proof of valid professional indemnity insurance.
- ❖ Proof of registration on CSD
- ❖ Proof of municipal rates and taxes or municipal service charges owed by the bidder AND ALL of its directors, not in arrears for more than 3 months. (The proof of municipal rates and taxes or municipal service charges to be submitted must not be older than three (3) months from the closing date of the bid. Attach valid lease agreement in case of rental of office facilities and municipal clearance in respect of the areas exempted from billing by municipalities.
- ❖ List of similar projects completed in the last 10 years by the consulting firm with description, client's contact details and contract values (Attach signed appointment letters and recommendation letters on client's letterhead)
- ❖ Company profile and CV's of the proposed project team.

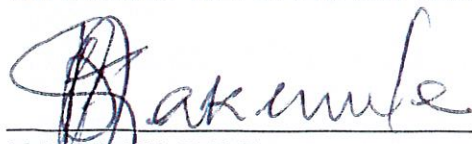

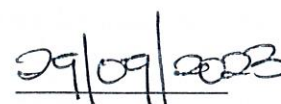
